Chief Winters presented the Fiscal Analysis and Forecast that Enloe Medical Center prepared on the operation of the Colusa Ambulance. This analysis reviewed current operational expenses, revenue and a 3-year forecast. Currently the ambulance is projected to have an \$830,170 operating deficit for 2022. The Colusa County Board of Supervisors EMS Committee will be meeting with Enloe in the near future to discuss the operation and future plans for the ambulance service.

There were 23 emergency incidents for the month of February: 1 fire which was vegetation, 18 EMS of which 8 were at the Colusa Casino or related facilities, 2 investigations and 2 mutual aid calls, 1 with Colusa Fire and 1 with Glenn-Colusa Fire.

There being no further business the meeting was adjourned until Tuesday, April12, 2022 at 6:30 PM at the Colusa Station.
