3. Discussion: Adoption of the 2022 California Fire Code.

Chief Winters reported that he and other Fire Chiefs had recently met with County representative to discuss the amending the 2022 California Fire Code for the County as it relates to illegal Fireworks to include Administrative Citations. After lengthy discussion the County Counsel staff, with the Board of Supervisors approval, declined to move forward with the necessary work to amend the Fire Code. This was due to lack of staffing and additional cost to County. The only alternative for Sacramento River Fire District is now to adopt the 2022 California Fire Code itself with Administrative Citations included. The cost is to do all of this unknown and would be a quite a lengthy process. After a lengthy discussion it was the consensus of the Board not to proceed further to adopt the 2022 California Fire Code to include Administrative Citation Clause for Fireworks violation. It was further decided to utilize public education to attempt to get the public to not use illegal fireworks.

## **COMMUNICATIONS: REPORTS AND PRESENTATIONS:**

Chief Winters reported that SSV staff has completed review of the County's Request for Proposal for ambulance service that was submitted by American Medical Response (AMR) and will be recommending to their Board of Directors to award the Ambulance Contract to AMR. It is anticipated that by end of January that the awarding of contract will take place.
