Colusa Rural Firefighters, Inc./Grand Island Firefighters:

No Firefighters present.

Fire Chief/CEO.

Chief Winters updated the Board on Measure A, Emergency Ground Ambulance Transportation. The Board of Supervisors approved an ordinance to collect the new transaction and use tax on 1-3-23. The ordinance becomes effective in 30 days.

An agreement with the State Tax and Fee Board has to be implemented before the tax can be collected.

A request for proposal has to be formulated by Sierra-Sacramento Valley EMS and approved by the Board of Supervisors and then let out to bid for ALS Ambulance Service. That process has been initiated.

It is hoped that a contract will be awarded 4-1-23.

The Board of Supervisors must establish criteria for the Citizen Advisory Committee and make appointments. It is not known where this process is at this time.

Chief Winters reported there were 33 emergency responses during the month of December 2022.

There were no fires, 25 EMS responses, 12 at Colusa Casino or related facilities, 2 mutual aid responses, 1 to Colusa Fire, and 1 to Glenn-Colusa Fire (Butte City), 3 investigations, 2 public assists, and 1 activated alarm.

There being no further business the meeting was adjourned until Tuesday, February 14, 2023, at 630PM at the Colusa Station.
