Approve Amendment to Real Property Lease Agreement with Colusa County Waterworks District #1.

Chief Winters presented the amended Lease Agreement with Colusa County Waterworks District #1. The Lease Agreement was reviewed by the Board in the August meeting, and it was recommended that the hold harmless portion of the Agreement include additional wording in regards to the district's liability in the future regarding the water treatment process and possible ground water contamination if discovered. Agreement was sent to legal council for review who then forwarded language to be stated in the Hold Harmless Clause.

Chief Winters reported that he and some of the volunteers have been working on getting signs out regarding Measure A. Currently 16 signs have been put out and 1 more will be put out within the week.'

Flyers have been mailed to Grimes, Stonyford and Princeton residents. Colusa residence will be receiving the flyer within the week. Public meetings have been scheduled for Princeton, Grimes, Stonyford, and Colusa. Maxwell, Williams and Arbuckle Fire districts have not done any kind of promotion of Measure A to the Chiefs knowledge.

OES Tender went out to the Mill Fire then went to the Coyote Fire and Mountain Fire in Siskiyou County beginning September 2<sup>nd</sup> and returning on September 14<sup>th</sup>. Volunteers have returned and will possibly be going to the Mosquito fire in Placer County.

There were 31 incidents in August: 2 vegetation fires, 14 EMS with 3 at the Colusa Casino, 7 Mutual Aid calls, 3 Investigations, 3 Public Assists and 2 Activated alarms.
