Fire Chief/CEO.

Chief Winters reported on the Annual Report and distributed a copy to all Directors and asked if anyone had any questions or concerns. Receiving no comments he stated that Directors were welcome to contact him if they had any questions in the future.

Chief Winters also stated all Directors had received a copy of the Ambulance Feasibility Study that the County Board of Supervisors had contracted AP Triton to complete. He stated that earlier in the day at the County Board of Supervisors meeting the Consultant (Triton) presented the report and a lengthy discussion was held regarding the length of time for the report to be completed, the contents of the report and the recommendation for ambulance service. The Board of Supervisors appointed a committee of Under sheriff Bradwell to represent Sheriff Department, Supervisor Corona and Smith and County Fire Chiefs with the committee to develop a short term, and long term plan for ambulance service for the County and how best to fund those deployment plan(s) and present those recommendations to the Board of Supervisors on December 14, 2021. Director discussion was held.

Under sheriff Bradwell left the meeting at this time.

Chief Winters reported there were 33 Incidents for the month of October. There were 3 fires, of which 2 were farm tractor fires, with an estimated dollar loss of \$14,850.00, 1 vegetation fire with no monetary loss; 16 EMS responses (8 were at the Colusa Casino); 3 Mutual Aids; 6 Investigations; 3 Public Assists; 1 Agency Assist and 1 Activated alarm.
