Draft of the Ambulance study was submitted to the County Administrator on September 15th and then was sent back to the Consultant to have them re-submit in a more understandable wording. The hope is that it will be presented to the Board of Supervisors sometime in October or November. It is Chief Winters understanding that there is nothing in the report that would address recommendations on how to fund the operation of the Ambulance. The report consists of current operations and future operations.

There was further discussion of the need for all County Fire Departments to have their Boards concur that the ambulance matter needs to be resolved. It was recommended that the Chief discuss with the other County Chiefs the thought of compiling a news release regarding the ambulance matter so that the public is more aware of the very serious

situation. Chief Winters stated he would attempt to make contact with the other County Fire Chiefs and see what their thoughts are on doing this news release.

Chief Winters reported there were 32 incidents for the month of September. There were 3 fires; all were vegetation fires with no monetary loss, 17 EMS incidents, 4 mutual aids, 6 investigations and 2 public assists.
