1. Approval of Claims for August 2022

Chief Winters presented the August claims in the amount of \$72,613.95 for payment, including \$22,227.18 in reimbursement for fire suppression for the "River Incident" May 24th to Colusa Fire, Williams Fire, Maxwell Fire, Princeton Fire, Meridian Fire, Sutter County Fire, Yuba City Fire, and Boggs Equipment (Dozers); \$23,048.00 Annual

Liability Vehicle, Structure Insurance and \$2,667.00 for Annual Volunteer Illness and Accident Insurance. The Fire District received \$45,769.56 for cost recovery for the River Incident from responsible party's insurance company, short discussion held.

Chairman Garner directed Chief Winters to contact the District's Legal Counsel at Lozano Smith for their opinion. Item continued to September 12, 2022, meeting.

Colusa Rural Firefighters, Inc./Grand Island Firefighters:

Fire Chief/CEO.

Chief Winters gave update on Campaign for Measure "A" Ambulance Service. Directors inquired about what other Fire Districts are doing. Chief Winters replied he had no recent contact with the other fire agencies, except Princeton who have piggy backed onto our campaign. Chief Winters further reported that sign boards are up in Colusa, Grimes and Princeton. Posters have been distributed and posted in above communities, informational letters are being put together for mailout in mid-September, and public meetings are being scheduled with the first one being held in Grimes on August 11th at 5:30 PM at the Grimes Library.

Chief Winters reported there were 45 incidents for July. There were 8 fires, 5 vegetation, 1 structure with \$50.00 damage, 1 debris, and 1 large wood chip pile; 20 EMS incidents with 8 at the Colusa Casino Resort or related facilities, 8 mutual aid, 4 with Sutter County Fire, 1 Colusa Fire, 1 Maxwell Fire, 1 Meridian Fire, and 1 USFS-MCKenny Fire Siskiyou County; 7 investigations, 1 activated alarm (medical) and 1 public assist.

There being no further business the meeting was adjourned at 7:35 PM until Tuesday, September 12, 2022, at 6:30 PM at the Grand Island Station.
